

1. Who can enter? Genting Reward members who are 18 years of age and older with a Genting Rewards Card who are eligible to participate. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
2. When? Earn entries beginning 8am on Monday, January 2, 2023, through 9:30pm on Saturday, January 28, 2023, the Earning Period. The Drawing Period is on January 28, 2023, 5pm-9:30pm with Ten (10) Drawings, Drawing One (1) 5pm, Drawing Two (2) 5:30pm, Drawing Three (3) 6:00pm, Drawing Four (4) 6:30pm, Drawing Five (5) 7:00pm, Drawing Six (6) 7:30pm, Drawing Seven (7) 8:00pm, Drawing Eight (8) 8:30pm, Drawing Nine (9) 9:00pm, Drawing Ten (10) 9:30pm, the Drawing Period.
3. How? Beginning Monday, January 2, 2023, Genting Rewards members may begin earning and printing entries for every fifty (50) with their Genting Rewards card properly inserted into a VLT or ETG. There is no limit to the number of entries a player may earn. Genting Rewards members who have earned the required points must print their entry at the device and deposit their entry into the physical drawing drum located at the Resorts World Bet Sports Bar located in the middle of the casino floor, ('Promotional Area'). The drawing drum will be open for earned entries beginning at 3pm. The drawing drum will close temporarily to perform the drawings. At 9:30pm on Saturday, January 28, 2023, one (1) name will be selected from the physical drawing drum.
