

1. Who can enter? Genting Rewards members who are 18 years of age and older with a Genting Rewards Card. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
2. When? Beginning Monday, January 9 through Tuesday, January 31, 2023, 12pm-8pm, each ('Promotional Day').
