March - June 2023, Rules

1. Who can enter? New Genting Rewards members who are 18 years of age and older with a Genting Rewards Card. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
2. When? Monday, March 20 – Friday, June 30, 2023, each a ('Promotional Day'), during normal operating hours.
3. How? Genting Rewards Program on initial sign up and download of Resorts World Hudson Valley (RWHV) Mobile App will receive \$10 Free Slot Play (FSP) when signing into the Resorts World Hudson Valley App for account holders. Qualified FSP earned during the period will be added to accounts and communicated on the App. It is the responsibility of the guest to ensure that their mobile card is properly connected to the machine at which they wish to print the FSP. This Free Slot Play offer must be printed at a slot machine by using the print feature within the App while the member's mobile device is connected to the slot machine. All Free Play must be played the day it is printed. This voucher will be valid on VLT machines. Vouchers are not valid on Electronic Table Games or Video Poker. Vouchers are non-transferable and may not be exchanged for cash. Falsification of any information renders the winner ineligible for the rewards and forfeits any claim to the reward. Other unique offers may be available to existing App users in the future. Users should visit Genting Rewards with questions about using the App. Eligible guests can only receive a maximum of one \$10 FSP voucher.
4. Prizes: Ten (\$10) in Free Slot Play once per Promotional period for new members downloading RWHV Mobile App and have signed into the RWHV App will receive FSP. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
5. Prize Acceptance: All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the member. Member is responsible for all taxes. By accepting a prize, the member acknowledges any and all restrictions, expiration dates and liabilities. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a

contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

11. It is the member's responsibility to confirm their card is inserted and registering play to be qualified for earning points and entries for drawings occurring for the month. It is the member's responsibility to keep all entries earned for the month to then deposit their entry into the physical drawing drum on said day of drawing. Any entry not deposited into the physical drawing drum will be disqualified from participation in the drawing. If a non-eligible entry is selected during the drawing, that name will not be considered eligible to be selected and will be placed to the side. A new entry will be selected.
12. RWHV is not responsible for typographical or printing errors, or any mechanical or technical malfunctions that may occur during a promotion.
13. Individuals on the self-exclusion list, exclusion list and individuals who are prohibited from entering the property are not eligible for participation in this promotion.
14. NYSGC will be notified immediately in the event of a cancellation or if the Promotion fails to run as submitted.
