

- 1. Who can enter? Genting Rewards members who are 18 years of age and older with a Genting Rewards Card are eligible to participate. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
- 2. When? Beginning Sunday, October 1 to Thursday, October 31, 2023, 10am 8pm, each a ("Promotional Day").
- 3. How? Genting Rewards members may redeem their Genting Rewards points earned at Resorts World Hudson Valley for Free Slot Play on the ('Promotional Days').
