

1. Who can enter? Genting Rewards members who are 18 years of age and older with a Genting Rewards Card who are eligible to participate. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
2. When? Earn entries beginning 9am on Thursday, June 1, 2023, through 4:45pm on Saturday, June 24, 2023, the Earning Period. 3. How?
