


- 1. Who can enter? Genting Rewards members who are 18 years of age and older with a Genting Rewards Card who are eligible to participate. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
- 2. When? Earn entries beginning 9am on Monday, July 31, 2023, through 4:45pm on Friday, August 25, 2023, the Earning Period. The Drawing Period is Fridays in August 2023, 4pm-8pm with Five (5) Drawings, Drawing Session One (1) 4:00pm, Drawing Session Two (2) 5:00pm, Drawing Session Three (3) 6:00pm, Drawing Session Four (4) 7:00pm, Drawing Session Five (5) 8:00pm, the Drawing Promotional Day.
- 3. How? Beginning Monday, July 31, 2023, Genting Rewards members may begin earning and printing entries for every ten (10) points, one (1) entry is printed at any VLT or ETG machine with their Genting Rewards card properly inserted. There is no limit to the number of entries a player may earn; however, you may only win once per a drawing. Genting Rewards members who have earned the required entries, must print their tickets that day at the device and hold onto those tickets until the day of each drawing. It will be the responsibility of the player to deposit their entries into the physical drawing drum located at the Resorts World Bet Sports Bar located in the middle of the casino floor, ('Promotional Area') on the day of the drawing. The drawing drum will be open for earned entries beginning at 2pm. The drawing drum will close temporarily to perform the drawings. The physical drum will not be open for up to five (5) minutes before each drawing period: 3:55pm, 4:55pm, 5:55pm, 6:55pm, and 7:55pm. After the successful declaration of a winner, the drawing drum will be reopened to receive entries for the remaining scheduled drawings. Players may deposit entries into the drawing drum until 7:45pm on Fridays in August 2023 fifteen (15) minutes before the last drawing to have their entries eligible to win.
- 4. On Fridays in August 2023, at 4pm, 5pm, 6pm, 7pm, and 8pm, one (1) name each hour will be selected from the physical drawing drum for \$300 in Free Slot Play or cash, its player's choice. The winner(s) names will be announced over the AV system. Selected Winners will have 5 minutes from the drawing time they were selected. If the selected winners do not arrive to the designated Promotional Area, Resorts World Bet Sports Bar within 5 minutes a new name or names will be selected. Winners need to be present to claim the prize. Names will be redrawn three (3) times for a winner to claim the prizes. If no winner has claimed a prize after the three (3) times then the prize will be forfeited.
- 5. Prizes: one (1) winner of three hundred (\$300) free slot play or cash in each hour from 4pm-8pm. Five (5) winners, totaling one thousand five hundred (\$1,500) in free slot play or cash each week. For the Promotion Period, there will be twenty (20) winners in total for Fridays.

If a non-eligible entry is selected during the drawing, that name will not be considered eligible to be selected and will be placed to the side. A new entry will be selected.
- 12. Individuals on the self-exclusion list, exclusion list and individuals who are prohibited from entering the property are not eligible for participation in this promotion.
