

1. Who can enter? Genting Rewards members who are 18 years of age and older with a Genting Rewards Card. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
2. When? Sundays in August [6, 13, 20, 27] 2023, during Genting Rewards Hours of Operation each ("Promotional Day").
3. How? Genting Rewards members can redeem their Genting Rewards points earned at Resorts World Hudson Valley. Points for Free Slot Play can be redeemed during Genting Rewards Hours of Operation on the Promotional Days at any VLT. The point exchange for redemption of free slot play is a 2:1 ratio and are redeemed via a DRS. Genting Rewards members earn one (1) point for every \$1 in theoretical loss. Members can redeem points for Free Slot Play at any VLT machine in \$5, \$25 or \$50 dollar increments. Once free slot play is redeemed, the appropriate amount of points will be deducted from the Genting Rewards member's account. Resorts World Hudson Valley will advertise through e-blast and interior signage in advance valid Promotional Days that members will be eligible to redeem points for Free Slot Play. Limit per day based on card type: Black tier \$500, Platinum tier \$250, Gold tier \$100, Silver tier \$50, Red tier \$25 each Promotional Day. The daily maximum limit of free slot play redemption for this program is controlled by the DRS system. Player's points will deduct from their casino points.
4. Prizes: Five (\$5) up to two hundred fifty (\$250) in free slot play.
5. Prize Acceptance: All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the member. Member is responsible for all taxes. By accepting a prize, the member acknowledges any and all restrictions, expiration dates and liabilities. Members may be required to complete and execute an Affidavit of Eligibility/Release of Liability, a Publicity Release and an IRS W-9. In addition, RWHV has the right to void any entry, and/or to change, cancel or modify this promotion at any time. 9. A minimum number of members must be checked in on the Promotional Day. If participation falls below the required minimum the promotion may be considered null and void, pending NYSGC approval.
10. It is the member's responsibility to confirm their card is inserted and registering play to be qualified for earning points and entries for drawings occurring for the month. It is the member's responsibility to keep all entries earned for the month to then deposit their entry into the physical drawing drum on said day of drawing. Any entry not deposited into the physical drawing drum will be disqualified from participation in the drawing. If a non-eligible entry is selected during the drawing, that name will not be considered eligible to be selected and will be placed to the side. A new entry will be selected.
11. Individuals on the self-exclusion list, exclusion list and individuals who are prohibited from entering the property are not eligible for participation in this promotion.
