

\$44,000 Cash Vault Drawing September 30, 2023 Rules

- 1. Who can enter? Genting Rewards members who are 18 years of age and older with a Genting Rewards Card who are eligible to participate. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
- 2. When? Players can earn entries beginning 9am on Monday, September 4, 2023, through 9:45pm on Saturday, September 30, 2023, the ('Earning Period'). The ('Drawing Period') is Saturday, September 30, 2023, at 10pm with four (4) Drawings occurring one after another. Drawing One: Four (4) winners winning \$1,000 cash, Drawing Two: Two (2) winners of \$5,000 cash, Drawing Three: One (1) winner of \$10,000 cash, and Drawing Four: One (1) winner of \$20,000 cash. Beginning Monday, September 4, 2023, Genting Rewards members may begin printing one (1) entry for every twenty-five (25) points earned at any VLT or ETG machine with their Genting Rewards card properly inserted. There is no limit to the number of entries a player may earn to participate in the drawing; however, you may only win once. Earned entries must be printed on the same day they are earned, or they are considered forfeited. Players are responsible for their entries as entries will not be reissued.

Starting at 7pm on September 30, 2023, players may deposit their entries for the drawing into the physical drawing drum located at the Resorts World Bet Sports Bar, the ('Promotional Area'). Players may deposit entries into the drawing drum until 9:45pm on Saturday, September 30, 2023, fifteen (15) minutes before the drawing to have their entries eligible to win.
