


- 1. Who can enter? Genting Rewards members who are 18 years of age and older with a Genting Rewards Card who are eligible to participate. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
- 2. When? Saturday, October 21, 2023, the ('Promotional Day'). Players will receive one (1) entry on Saturday beginning at 10am for the drawing from 5pm 8pm, having four (4) drawing sessions. Session one (1) 5:00pm, session two (2) 6:00pm, session three (3) 7:00pm, session four (4) 8:00pm, the ("Drawing Period").
- 3. How? Saturday, October 21, 2023, Genting Rewards members will print one (1) entry from the kiosk to deposit into the physical drawing drum. Players will deposit the PKMS ticket and may only win once per drawing session. It will be the responsibility of the player to deposit their ticket into the physical drawing drum located at the Resorts World Bet Sports Bar near in the middle of the casino floor ('Promotional Area'), for the drawing. Each of the four (4) winners will be instructed to reach their hand into a cauldron selecting one (1) envelope with free slot play valued from \$100 to \$500. Each session will begin with 18 envelopes. Winners will be awarded their chance to select an envelope based on order drawn. Awarded envelopes will not be put back into the cauldron until the conclusion of each session. Once CASH has been awarded to the winners' account the envelopes will be placed back in the cauldron for the next drawing session, keeping the same amount of envelopes in the cauldron for all the drawings. You may only win once per a drawing session. The drawing drum will be open for the one (1) entry beginning at 3pm. The drawing drum will close temporarily to perform the drawings. The physical drum will not be open for up to five (5) minutes before each drawing period: 4:55pm, 5:55pm, 6:55pm, and 7:55pm. After the successful declaration of winners, the drawing drum will be reopened to receive entries for the remaining scheduled drawings. Players may deposit the one (1) entry until 7:55pm on Saturday, October21, 2023 five (5) minutes before the last drawing to have their entries eligible to win.

Saturday, October 21, 2023, at 6pm, 7pm, 8pm, and 9pm, four (4) winners each hour will be selected from the physical drawing drum. The winners' names will be announced over the AV system. Selected winners will have 5 minutes from the drawing time they were selected to make their selves known at the Resorts World Bet Sports Bar, the ('Promotional Area'). If the selected winners do not claim their prize within 5 minutes a new name or names will be selected. Winners need to be present to win. Names will be redrawn three (3) times for a winner to claim the prizes. If no winner has claimed a prize after the three (3) times then the prize will be forfeited.

- 4. Prizes: Four (4) winners of one hundred (\$100) up to five hundred (\$500) in CASH each hour from 5pm-8pm.
