

1. Who can enter? Genting Rewards members who are 18 years of age and older with a Genting Rewards Card are eligible to participate. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
2. When? Players can earn entries beginning at 9am on Monday October 30, 2023, through 9:45pm on Saturday, November 11, 2023, the ('Earning Period'). The ('Drawing Period') is Saturday, November 11, 2023, at 10pm. Drawing one (1) a Dodge Charger.
3. How?
